 - (a) 25% of sale amount (less EMD paid) within 15 days from the date of sale communication letter.
 - (b) Balance 75% of sale amount within next 30 days.
 - (c) Any default in these payment terms would automatically disqualify and nullify the sale transaction with forfeiture of all amounts paid including EMD. Further, KSIIDC retains the right to put the same assets for re-sale and complete the sale transaction in all respects.
 - (d) EMD shall not carry any interest and will be refunded to unsuccessful bidder after conclusion of sale proceedings.
3. Successful bidder / purchaser shall get the sale deed prepared, executed in respect of the land and building and shall bear all expenses incidental to the sale and registration thereof.

4. Purchaser of plant & machinery shall bear the applicable Sales Tax / Value added tax (VAT) separately.
