**Corrigendum**

The contents figuring out against item no (c) and (d) in the Government Order bearing No. IDD/78/ITS/2009 Bangalore, dated 09-12-2009 may be modified and read as hereunder;

- (c) KSIIDC would formulate the documents for procurement of an SPV with the equity share holdings by the private sector and Government of Karnataka shall hold a 'Golden Share' in the proposed SPV. The private sector enterprise in charge of the SPV shall initiate immediate action to allot the golden share to the Government of Karnataka, no sooner the incorporation of the SPV.
- (d) It shall be specified in the procurement documents that, pre-defined percentages of the port space would be made available for usage by the Government or its agencies or VADA and the balance to be used by the developer. The defined percentages would be fixed on the basis of detailed feasibility report/DPR.
